## NIACC and ABC Announce Climate Control Articulation Agreement

North Iowa Area Community College and the Associated Builders and Contractors of Iowa celebrated the announcement of a new Climate Control articulation agreement this fall.

"We are pleased to partner with the Associated Builders and Contractors of Iowa on this agreement in an effort to provide strong preparation to students looking to enter the field," Dr. Deb Derr, NIACC president, said. "This agreement marks yet another step in our efforts to connect NIACC students with key industry players and train the skilled workforce of the future."

The agreement allows NIACC Climate Control students to count their two-year degree as all four years of their apprenticeship training, which is required for licensure as an HVAC technician in the State of Iowa. Students who complete the program now have a credential from the U.S. Department of Labor which is recognized across the country.

"This partnership with the Associated Builders and Contractors of Iowa reflects their confidence in the NIACC curriculum for Climate Control students. It's an honor to earn such a vote of confidence in the training we're providing," Josh Byrnes, NIACC industrial

technology division chairperson, said.

The Associated Builders and Contractors of Iowa, a chapter of a national organization, serves as one of the few organizations that can grant apprenticeship credits as needed to earn HVAC technician licensure in Iowa.

"We are thrilled to have this partnership. With this agreement, we are putting the industry seal of approval on the program here

at NIACC with one of the most state-of-the-art facilities in the HVAC industry as far as community colleges go," Tom Fulcher, Associated Builders and Contractors of Iowa education director, said.

## NIACC and UNI Announce Information Technology Articulation Agreement

North Iowa Area Community College and the University of Northern Iowa celebrated the announcement of a new Information Technology articulation agreement this fall.

"NIACC is proud of its longstanding relationship with the University of Northern Iowa. This relationship has always centered on providing a quality educational experience for our students and providing them with a convenient pathway to a bachelor's degree. It is an exciting day to solidify yet another seamless path for our students to follow," Dr. Mark Johnson, NIACC vice president for academic affairs, said.

The agreement, signed by both institutions' vice presidents for academic affairs, makes it possible for students to earn an Associate of Arts degree with coursework in computer science at NIACC in two years and transfer seamlessly to earn their Bachelor of Arts in computer science at UNI in two years.

"UNI Computer Science has a great relationship with NIACC and its graduates. This articulation agreement creates another avenue for us to serve the students of Iowa and prepare them for high-tech careers in the state," Eugene Wallingford, UNI associate professor and head of the department of computer science, said.

Faculty from both institutions worked together to create the articulation agreement for students.

"We are very pleased and honored to have UNI select NIACC as the first community college in Iowa to work with on this project. The high quality of our Information Technology students transferring to UNI was the reason they approached us for this articulation agreement with their Computer Science department. That is a great compliment to our IT faculty and programs and we are very excited for this opportunity to help our graduates make a smoother transition to UNI," Mary Mosiman, NIACC information technology program leader and instructor, said.

Misty Frank, who earned her Associate of Arts degree from NIACC in 2002 and her Bachelor of

Arts degree in computer science from UNI in 2005, said both institutions made a difference in her life.

"The educational background I've received from NIACC and UNI has provided me with a foundation that has helped me to attain success and opened opportunities that I otherwise may have not thought possible," Frank said. "I highly value my experiences that took place on the NIACC and UNI campuses."

After earning degrees from both NIACC and UNI, Frank will earn her Master of Business Administration degree from the University of Iowa in December 2009 and is working toward her Master of Science degree in systems engineering from Iowa State University. She currently works as a software quality engineer at Rockwell Collins where she applies a systematic, disciplined, and quantifiable approach to the construction, analysis, and management of software and system processes and procedures.

## Workforce Development Partnership Offers Veteran Services

The Workforce Development Partnership (WDP) between Iowa Workforce Development (IWD) and North Iowa Area Community College offers veteran services to help put Iowa veterans to work.

With all of the skills veterans acquire in the military, one of the biggest challenges can be deciding how and where their military skills will transfer into this new job market. The WDP can help veterans make the leap as well as tackle other issues by using the resources of the IWD Center.

"Our effort to help veterans in search of jobs is one of the most important things we do," Nancy Bair, IWD Center director, said. "Through our veteran priority of service, veterans have first choice when accessing individual classes or programs at the IWD Center. Our veteran services work to match veterans' skills with jobs and help veterans succeed."

The veteran priority of services allows veterans to go to the front of any waiting list for any class and holds reserved slots for veterans in specific program offerings such as IWD Center computer classes. Other veteran services offered by the WDP include assessment tools to evaluate veterans' skills and interests; one-on-one confidential counseling

for job assistance, personal, and family needs (food, clothing, and shelter); an automated system to contact veterans about potential job openings; information on the availability of jobs in a specific field and assistance in contacting employers regarding job openings; access to programs, classes, and videos to assist in work search; special assistance available on a case-by-case basis for veterans with disabilities or those facing serious barriers to finding employment (assistance is also available to other veterans on a case-by-case basis); and information and referral services to outside support agencies for veterans and veterans' families.

The WDP has earned the Veteran Incentive Award for outstanding service to Iowa's veteran community for the past two years and was the top scoring One Stop in the state this year.

The IWD Center also offers clients internet access, computer software, placement assistance, office equipment availability, unemployment insurance and printed resources.

## New/Updated Programs @ NIACC

**Pharmacy Technician Certificate Program** – NIACC has created a new certificate program for students interested in becoming pharmacy technicians. Effective July 2010, pharmacy technicians in Iowa will need to be certified. The new program will assist students in preparing to take the certification exam.

**Network Administration and Security** – The Information Technology faculty have updated and combined NIACC's Network Administration and Cyber Security programs to better meet industry and employment needs. Graduates of the combined program will have a strong skill set and multiple employment options.

**Microsoft IT Academy** – NIACC's Information Systems Technology program has achieved accreditation as a Microsoft IT Academy, which will enhance student access to Microsoft certification and employment. Program enhancements from this new status include e-learning opportunities, software downloads for curriculum and virtual systems for training.

**Wellness, Exercise Science and Leisure Services** – NIACC has updated its Health and Wellness program and re-titled the program to Wellness, Exercise Science and Leisure Services to better reflect areas of specialization in this field. Graduates of this program can transfer to a four-year program or enter the job market directly after graduation from NIACC in such areas as fitness, corporate wellness and recreation.

**Climate Control Technology** – NIACC's Industrial Technology Division has enhanced training and employment opportunities for its Climate Control students by developing an articulation agreement with Associated Builders and Contractors of Iowa. (See page 1 for more details.)

**Welding Certificate Program** – NIACC has reactivated its Welding Certificate program in response to a growing demand for short-term training, particularly among dislocated workers in Iowa.

**Developmental Education** – During the past year, NIACC faculty have made several changes to the College's Developmental Education program, which is designed to assist underprepared students in preparing for college-level work. The College has added new course options for students needing additional preparation in reading, writing and math.

### New Continuing Education Initiatives

- The "Administrative Professional Certificate" is a new series of classes designed to increase employee effectiveness in improving productivity and communications within the office environment.
- The Lifelong Learning Institute, a membership-based program, provides opportunities for members to engage in educational activities that provide opportunities for fun, friendship and college-level learning.
- A "Master Chef Certificate" program has been developed to help participants improve their home cooking skills and to learn about the rigors and challenges of employment as a professional chef.
- The "Certificate in Supervision" program is a series of classes that will provide the participant with the skills needed to become an effective leader in today's business environment.
- The Certified Nurse Aide program, which is traditionally delivered in a classroom environment, has been converted to a hybrid model of delivery, effectively combining online course instruction with onsite skills training and testing.
- The Lean Enterprise movement continues to expand with the creation of the Lean Breakfast Club. The club was formed as a partnership between NIACC and Mercy Medical Center–North Iowa in order to increase participants' knowledge of the Lean culture by having members review the latest books written about the Lean Enterprise.
- The Ultimate Sales Academy, originally offered as a six day course to develop and practice professional business to business selling skills, continues to expand with the development of customized courses delivered onsite to business and industry.

# NIACC Extreme Makeover: College Edition Winners Announced

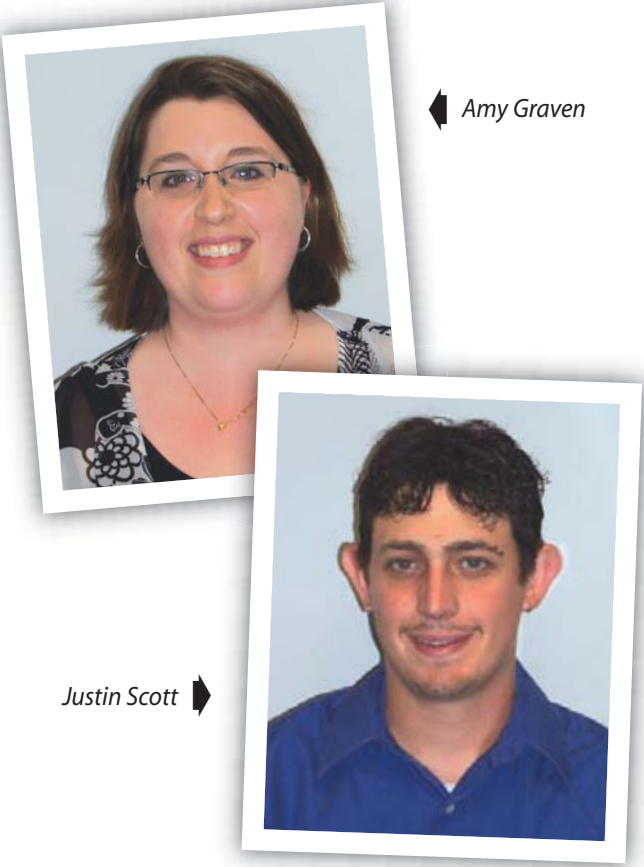

# Service in Action – NIACC Students Journey to Mississippi

During the NIACC Spring Break 2009, 16 students joined the growing trend of more college students choosing to spend spring break working for volunteer service missions rather than flying to sunny vacation spots. Brent Hamilton, NIACC math instructor and campus ministry advisor, coordinated the week-long service trip to Waveland, Mississippi, where students worked for Katrina Relief projects.

"Waveland was one of the many towns that were damaged by Hurricane Katrina. Even though it has been nearly four years, there are still a large number of restoration projects remaining in the region," said Hamilton. This marked the second year Hamilton has taken a group of NIACC student volunteers on a mission trip to the Gulf of Mexico region but the first time working through the Katrina Relief organization. Katrina Relief is one organization that coordinates volunteer workers for home and city restoration projects in Waveland.

Mark Messer, NIACC communication skills instructor; Dr. John Nolan, Mason City; Hamilton; and the NIACC students left early on Saturday, March 7, for their volunteer service experience. In order to keep costs for the students at a minimum, the first night's accommodations were spent sleeping on the floor of First United Methodist Church in Blytheville, Arkansas. By Sunday evening the group reached their destination at the camp in Pass Christian, Mississippi, which would be their home for the week of service. To stretch their budgets even further, students pooled money to buy groceries and cooked their own meals while they were at the camp. The camp, operated by Katrina Relief, charged a minimal fee of \$5 per day per student and provided a hot water shower for everyone. While at the camp, NIACC students were joined by other student service groups from Illinois, New York and North Carolina.

Katrina Relief had numerous projects which kept the students busy during the four days they were scheduled as volunteers in Waveland. NIACC students and the adult leaders were divided up into three work groups. They worked at putting in windows and doors, hanging drywall, digging ditches for water lines, stripping decks, building fences, and planting 40 bushes in the city park. The completion of these projects made a difference in the lives of the residents at Waveland and their goal of returning to pre-Katrina conditions.

The journey did include some rest, relaxation, and fun for the students. Relief volunteers enjoyed a Louisiana Cajun Encounters swamp tour (complete with a sighting of Cindy the Alligator). When they were not volunteering, the group went to the beach on the Gulf of Mexico for swimming, volleyball and relaxation by the ocean. A detour to New Orleans and a visit to the French Quarter were included on the return trip home.

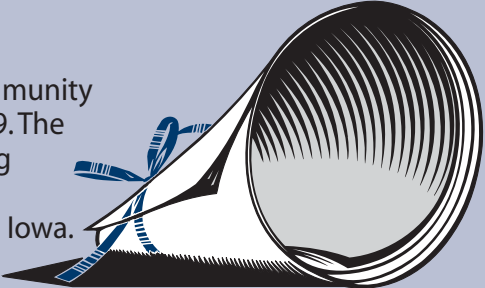
All told, each student spent approximately \$100 for their week-long service trip, a small price to pay for a tremendous life experience. "Our trip was funded through the NIACC student Campus Ministry Association (CMA)," said Hamilton. The CMA, a NIACC student organization, budgeted about \$1,900 to cover the hotel stay, T-shirts for the students and gasoline.

"We had a good mixture of students and adult leaders along for the service trip," said Hamilton. Students, who had not normally interacted on campus during the semester, spent their week of spring break meeting new friends and helping others less fortunate. As one student commented, "We went down to Mississippi as strangers and came back as friends."

# Schutte Takes Part in Global Change Workshop

North Iowa Area Community College biology instructor, Carol Schutte, is one of 26 scientists recently chosen to attend a global change workshop in Costa Rica sponsored by the National Science Foundation. Schutte considers herself very fortunate to have been selected to participate in the workshop.

"This was a remarkable opportunity to immerse myself in tropical studies. I've been on several trips to the tropics, including taking students to Belize and Costa Rica, but this time I wasn't the one counting noses on the bus! I was the engrossed student," Schutte said.

During a three-week global change and tropical ecosystems workshop, organized by the Organization for Tropical Studies (OTS), professionals from a dozen countries in Latin America and the United States addressed current issues facing tropical ecosystems. Workshop participants discussed how changes in average annual temperature and precipitation patterns can have profound effects on the biodiversity of tropical ecosystems. The conference was held from April 22 to May 14, at three OTS biological research stations in Costa Rica, primarily at La Selva Biological Station in Sarapiquí, Heredia.

"This workshop aimed to analyze the challenges currently being faced for research and conservation in tropical ecosystems in the face of global change. Along with this, the long-term research results from La Selva Biological Station were compared with the results obtained at other stations such as Monteverde, Palo Verde and Las Cruces that were also visited as part of the course," explained Delphine K. Farmer, University of Colorado, and assistant coordinator for the workshop.

As part of this international workshop, OTS hosted a symposium on April 26 and 27 at La Selva. Invited guests presented talks on the importance of climate change and the challenges of presenting complex information to students at all levels, educators, policymakers, people from different cultures, and the general public. The symposium was sponsored by the National Science

Foundation - Research Coordination Network (RCN NSF). Speakers shared their position and the initiatives they are developing to improve environmental conditions and responses to global climate change.

"The lectures were stimulating and sometimes overwhelming and depressing. Yet at the same time it was encouraging to be among such committed and energetic people," said Schutte in retrospect. "I believe I have made some new lifelong friends who share my same passion for improving science literacy and environmental protection."

The Organization for Tropical Studies (OTS) is a non-profit consortium that has grown to include over 60 universities and research institutions from around the world. OTS was founded in 1963 to provide leadership in education, research and the responsible use of natural resources in the tropics. To address this mission, OTS conducts graduate and undergraduate education, facilitates research, participates in tropical forest conservation, maintains three biological stations in Costa Rica, and conducts environmental education programs.

Dr. Deb Derr, NIACC president, signed the American College & University Presidents' Climate Commitment and the Energy Star participation certificate on behalf of NIACC this fall.

"We are excited to make this historical step as NIACC officially commits to pursuing climate neutrality and improving building energy efficiency," Derr said. "Through the American College & University Presidents' Climate Commitment and participation in the Energy Star program, we continue our work to reduce our environmental impact and educate our students on the importance of doing so."

As the fight against global warming shapes the 21st century, colleges and universities must exercise leadership by modeling ways to eliminate global warming emissions and by providing the knowledge and the educated graduates to achieve climate neutrality. Through the American College & University Presidents' Climate Commitment, NIACC will initiate the development of a comprehensive plan to achieve climate neutrality as soon as possible; initiate tangible actions to reduce greenhouse gases while the more comprehensive plan is being developed; make the action plan, inventory and periodic progress reports publicly available by providing them to the Association for the Advancement of Sustainability in Higher Education (AASHE) for posting and dissemination.

As a partner with the U.S. Environmental Protection Agency's Energy Star program, NIACC commits to protecting the environment through energy efficiency and improving building energy efficiency by ten percent or more. This partnership strives to implement and promote energy efficiency improvements that lower energy costs and reduce the risks of global warming.

"As part of our work to move these new initiatives forward, we're forming a committee made up of faculty, staff, students, and potentially community members to focus on our sustainability efforts," Tony Pappas, NIACC director of facilities management, said. "We are fully committed to minimizing our carbon footprint and continuing to do our part through energy efficiency."

Also new for students returning to campus this fall, NIACC has implemented the use of environmentally friendly food service disposables such as plates, bowls, cups, and silverware.

"It's exciting news as NIACC begins to go green. I've researched suppliers for compostable products that also

maintain a standard in presentation and hold food products properly," Ken Webber, NIACC director of food service, said. "Most of our new items will come from Eco Products where they're produced as certified products in an environmentally friendly building. Having worked in Food Service for over 30 years, I'm pleased to help NIACC step forward and set an example of giving back to the planet."

The new products will include 100 percent recycled materials napkins by Tork; 12" and 16" cups that hold heat but are not hot to touch from Solo with Duo Shield; and 9" plates, 6" plates, 10" three-compartment plates, 16 ounce cold cups with lids, 10 ounce bowls, and silverware from Eco Products. The Eco Products items are compostable, which means that 90 percent or greater degradation of the materials occurs within 45-120 days and no toxic residue remains in the final compost. And, although the products will still go to the landfill, the front-end benefits make them extremely beneficial to the environment. The items are made from rapidly renewable resources and reduce dependence on oil, take less energy to produce relative to petroleum counterparts and use an already used resource through sugarcane.

NIACC will use the new environmentally friendly food service disposables on campus and for catering. The NIACC dorms are already environmentally friendly through the use of dishes that are washed and the elimination of trays last year.

All these new initiatives mark the latest efforts by NIACC to reduce environmental impacts. The College currently realizes energy savings through the new Recreation Center design as well as a multitude of other energy efficiency savings across campus.

## Robot Donated to NIACC Industrial Division

The North Iowa Area Community College Industrial Division has received a generous donation of a restored Yamaha YK740 (a 20 kilogram 4 axis SCARA robot) from Robert Franken, electromechanical instructor at NIACC, for use in the Programmable Logic Controllers (PLC) and advanced automation labs at the College. The donation was made through the NIACC Foundation.



"The Yamaha YK740 will be an excellent hands-on tool for students taking Advanced PLC and System Integration," said Franken.

Prior to accepting a position in the Industrial Division at NIACC, Franken gained real-world experience with robots used in the manufacturing process. From 1981 to 2006, Franken worked as a senior electrical engineer at Eaton in Belmond. After Eaton, Franken took a job as the engineering/ maintenance manager for AGC Flat Glass in Hampton, Iowa, from 2006 to 2008. Programming robots and integrating control systems into the manufacturing environment was a primary function of Franken's job at Eaton. "Part of my job at Eaton was to check the quality analysis of production parts using a robot similar to the Yamaha YK740," said Franken. The YK740 will now bring real-life experience for students into the PLC lab at NIACC.

Robotics and their operational principles are used in a diverse mixture of industry applications, from manufacturing processes to wind turbines. The ability to set-up, operate and repair PLCs are skills that will be in demand for manufacturing positions that utilize advanced technologies. "My plans are to have the students integrate the robot (YK740) to a PLC with a color vision system. It will be checking the quality analysis of production parts in an application like I used to do as the senior electrical engineer at Eaton," said Franken.

Since the introduction of the YK740, two more robots have joined the NIACC PLC lab - a six-axis Kawasaki articulated arm robot and a four-axis Yamaha Cartesian robot. These three units make up the robotic cell for the advanced PLC labs and the computer automated manufacturing labs. "These robots have added three components to the Advanced PLC and System Integration curriculum: Cartesian robotics, articulated arm and SCARA robot," said Franken. When combined into a robotic cell, the three robots will provide the opportunity for students to learn the operations performed by all three robot types. Operations performed will include how robotics impact the system process of computer automated manufacturing labs.

One of the future goals for the PLC labs is to incorporate a vision and wireless control system into the robotics cell. This system will take the PLC lab curriculum to the next level. "Our goal is to present real world applications for our students and the vision and wireless control system will bring that experience into the classroom," said Franken.

Thanks to Franken's generosity, NIACC students will now gain hands-on experience in the world of robotics and how the robotic cell system is utilized in the manufacturing process. ## NIACC Graphic Communication Students Capstone Projects Benefit *Habitat for Humanity and North Iowa Fair*

Students in the Graphic Communication and the Web Design capstone classes at North Iowa Area Community College were involved with two major projects last spring – creating marketing materials for the Habitat for Humanity ReStore and the North Iowa Fair. It marked the sixth year that Norb Thomes, NIACC instructor for both capstone groups, has solicited volunteer projects from the community for capstone classes.

"We try to help charities and non-profits in these classes (capstone graphic communication and web design). It's a great experience for the students to work with real clients and a chance for folks that are trying to do good to get new stuff for small investments," said Thomes. The scope for these projects covered everything from development of tri-fold brochures, truck decals, posters, and even a display booth for use at exhibitions. Upon completion of these projects, these capstone students will have invested a total group average of between 600 to 700 hours of volunteer time to Habitat for Humanity ReStore and North Iowa Fair projects.

The students that comprised the team that recently completed construction of a new display booth for use by the Habitat for Humanity ReStore included: Britt – Sarah Everett; Mason City – Ryan Adams and Christine Funk; Northwood – Cameo Fjelstad; Riceville – Jacqie Klein; and Camp Verde, AZ – Aaron Hancock. ReStore, a retail business under the umbrella of Habitat for Humanity, collects new and "gently used" building materials and re-sells them at a large discount. This keeps usable materials out of the landfill, supplies low-cost materials for building and remodeling, and raises money to help build new homes through Habitat for Humanity.

The new display was completed just in time for use by Habitat for Humanity ReStore during last year's Home Show held at the North Iowa Fairgrounds. The ReStore booth would normally cost over \$1,000 if purchased from a promotional supplier, even if it had been a used booth. Thomes students were able to construct the booth, complete with discount graphics from Sign Pro and recycled materials from the ReStore, for a price of \$100.

In addition to the display booth, capstone students also created a marketing plan, store decorations, and signage and a video for the ReStore along with logos for the outside of the Habitat for Humanity cube van and trailer.

"Volunteer projects like ReStore and North Iowa Fair are a win-win for the students and the organizations. Students work as a team to create the marketing materials and the organization gains a new marketing look without breaking their budget," said Thomes.

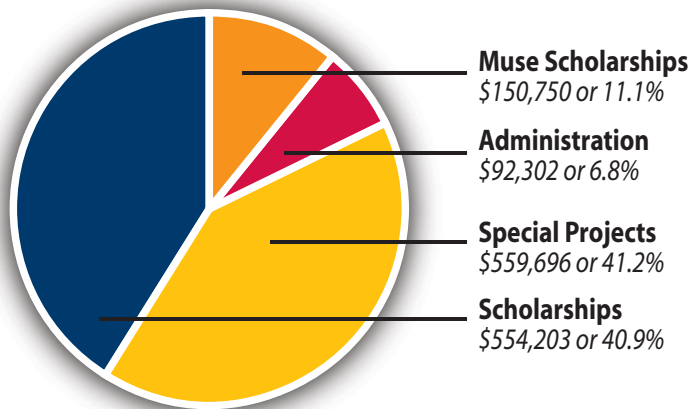

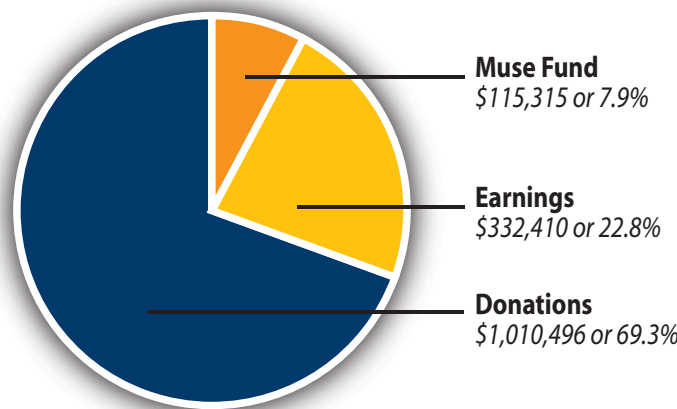

"In these tough economic times, scholarship donors allow students the opportunity to fulfill their dreams without burying themselves in debt. Education is a necessity, and without these scholarships, some students may not have the opportunity to achieve their goals."

After graduating from NIACC, Aussenhus plans to attend Iowa State University to major in Architecture.

Nora Benjamin, a social work major from Oakdale, Minn., noted that the kindness of scholarship donors has allowed her to get an education and experience college life as well. Benjamin received the 75th Anniversary Scholarship.

"Having received a scholarship for music has helped because that amount of money that is going toward my education is just a little less that I have to stress about," Benjamin said. When people give money for one of these students to go to college, it means all the less debt that the student will need to go into."

After graduating from NIACC, Benjamin plans to attend the University of Northern Iowa for a Bachelor's degree in social work and then earn her Master's degree from Mankato State University in rehabilitation counseling.

Scott Byers, a secondary education major from Forest City, felt that scholarships allowed him to avoid college debt and focus on his studies. Byers received an Area 2 High School Scholarship, a Robert and Lois Bergland Scholarship, a John and Mary Pappajohn Scholarship

and a NIACC LINK Scholarship.

"The scholarships I've received have had a huge impact on my success at NIACC. I have been able to cut back on my hours at work without the added financial pressure. This has allowed me to concentrate fully on my classes and focus on completing my coursework," Byers said. "For many, scholarships are a huge determining factor of attending college at all. Scholarships give people the opportunity to better themselves and reach their fullest potential through continuing their education."

After Byers graduates from NIACC, he plans to transfer to the University of Northern Iowa to earn his Bachelor's degree followed by a Master's degree in education administration. Byers plans to teach high school social studies and then pursue a career in high school administration.

As the cost of higher education continues to increase, so does the need for student financial assistance in the forms of loans, grants and scholarships. Scholarship donations help students keep their borrowing to a minimum. While the College experiences great support from groups and individuals each year, the need remains for private support of the NIACC Foundation.
